

## **UNANIMA INTERNATIONAL'S WOMAN OF COURAGE FOR 2017!**

**Marietta Latonio** is a social worker who lives and works in Cebu, Philippines. She has been the director of many welfare programs; led



implementation of community-based

programs for more than 20 years; worked for many NGOs focused on the welfare of women and children; has been a lifelong advocate for children's

human rights, and more recently involved with the "I Have a Voice" research project.

She is now the monitor / evaluator of programs at Good Shepherd Welcome House in Cebu. Not only does she work with and support girls and women on the street; but she educates pimps about trafficking, and networks with bar managers in an effort to identify and help women in need.

Marietta has done many international presentations, and is now getting a degree with research focused on interventions for recovery of trafficking survivors.

### ANOTHER KIND OF DISCRIMINATION

The "3rd Committee" of the UN General Assembly deals with social issues and human rights. In following the 3<sup>rd</sup> Committee last fall, the 2016 interns were especially interested in a panel on discrimination, at which one panelist was a young girl with albinism. She discussed the discrimination and persecution of albino people, especially boys and girls. Albinism is an inherited disease in which the skin produces very little pigment in the skin, hair, and eyes. Many albinos contract skin cancer because they lack

hardest burden is the social ostracism that leads to stress, low self-esteem, isolation, fear, and even violence. In some African countries the body parts of individuals with albinism are sought after by witch doctors; there have

been numerous cases of children with albinism murdered for profit. In 2013 it was estimated that the body parts of an albino could net \$75,000 (National Geographic). The UN office of the High Commissioner for Human Rights is trying to raise awareness for protection of the rights of persons with albinism. The picture features Tanzanian children.

### CLIMATE CHANGE CONFERENCE IN MARRAKECH

The UN Climate Change Conference (COP22) brought together over 22,500 participants, including nearly 15,800 government officials, 5,400 representatives of UN bodies and agencies, intergovernmental organizations and civil society organizations, over 70 heads of state/ government, and 1,200 members of the media. Negotiations in Marrakech focused on matters relating to the agreement's "entry into force" and the implementation of the Paris Agreement. Member States adopted 35 decisions, which provide guidance on the completion of the work program under the Paris Agreement, and address long-term finance, technology development / sharing, gender issues, adaptation, education and public awareness, and how to help countries adapt to climate change.

Fiji offered to preside over the next climate change conference, (COP23) to be held in Bonn in 2017. As a very vulnerable nation, Fiji wants to place climate change at the top of the development agenda. They issued an invitation to Donald Trump saying "You came to save us during World War 2; it is time to save us now." Poland will host COP 24 in 2018.

# REPORT ON THE RIGHTS OF CHILDREN IN THE CONTEXT OF MIGRATION

This report, (<a href="http://www.un.org/ga/search/view\_doc.asp?symbol=A/71/413">http://www.un.org/ga/search/view\_doc.asp?symbol=A/71/413</a>) issued by the 71st UN General Assembly last year, examines the status of the implementation on the *Convention on the Rights of the Child*, with a particular focus on migrant children.

### WATER CONNECTS THE SDGs

In late November a Budapest UN Water Summit (the one that in 2013 called for a stand-alone sustainable development goal on water) convened, with Hungarian President János Áder stating that water is the most significant issue of the 21st century. He noted that responsible water management is a prerequisite for development, and cited examples of water issues worldwide, including the link between water scarcity and conflict, and impacts of climate change on irrigation and hydropower production.

Other officials noted the links between water, peace, and security, the problems involved in transboundary water agreements between nations, and the special plight of small island nations experiencing increased drought and groundwater contamination.

- 90% of human loss of life from natural disasters comes from waterrelated events
- It is forecast that global water demand will increase by at least 55% from 2000-2050
- 80% of African countries' Nationally Determined Contributions under the UN Framework Convention on Climate Change (UNFCCC) were about water issues
- global water use has tripled since 1950
- 80% of wastewater is discharged back into the environment without any treatment
- 2.5 billion people lack access to basic wastewater treatment

Csaba Balogh of the Hungarian Ministry of Foreign Affairs and Trade quoted John F. Kennedy: "Anyone who can solve the problems of water will be worthy of two Nobel Prizes: one for peace and one for science."

### SAMPLE STORY FROM GLOBAL SISTERS REPORT

Here is a compelling news story out of India about <u>Sr. Valsa John</u>, a Catholic sister who fought to protect the land and rights of tribal people in Jharkhand state from heavy coal-mining interests. She was murdered in 2010 at age 53. Her death set off an international interest in her story and the plight of illiterate tribal people in India who join the "mining mafia" as a means of income and are often exploited by these companies. **Mary** Josée Therrien **RJM** reports that they have joined the *Water With Blessings* family! Their sisters in Aleppo, Syria are delivering filtration systems to families, in collaboration with Franciscans, Larraine Lauter **OSU**, and others.

We also heard from the RJM Province of Baroda, India, where the



among tribal groups in about 70 villages of Panchmahal District, Gujarat State. The people are mostly illiterate migrant laborers with no means of livelihood, and the sisters have about 600 children in their school, of whom 160 are boarders. Some are orphaned street children, and the sisters presently are trying to raise money to build another school building so they can take more tribal children. • The Ursuline Sisters of Mount St. Joseph are very active in Region 6 of the Leadership Conference of Women Religious and the Interfaith Center on Corporate Responsibility, and recently signed onto two letters to oppose human trafficking and forced labor. One letter joined with the Alliance to End Slavery and Trafficking (ATEST) to request federal funding to fight trafficking and forced labor according to Trafficking Victims Protection Reauthorization Act of 2013. The second letter addresses information technology companies about the use of forced labor and slavery by their suppliers. Several Sisters of Saint Agnes who live on the USA/ Mexico border

are taking action on behalf migrants and refugees. Susan Kolb CSA (picture) is Managing Attorney of a southern Arizona legal aid office which provides civil legal services to the poor in three counties. Other Sisters work in a Migrant Resource Center (in Mexico) with migrants who have been "repatriated" – i.e., deported from the USA. This effort is a binational humanitarian project.

Another program launched by the **CSA** Sisters is in inner city Milwaukee, Wisconsin. CORE-El Centro <a href="http://www.core-">http://www.core-</a> <u>elcentro.org/</u> serves a population that is about 70% Latino. Many recent immigrants feel isolated. The organization aims to create access, build community, and inspire wholeness. In addition to providing the best medical care at the Free Clinic in the facility, they also offer acupuncture, exercise programs and massage. Through their roof-top garden they are able to teach classes in gardening, and help with improved nutrition.


## A NEW YEAR'S GIFT FOR YOU!
